D/Cllr Sanderson updated the group that the current licencing issue was a renewal but did not include the cheetahs. Mr & Mrs Ashman will have to apply for a Dangerous Animals Act Licence for the cheetahs, but this will be only a personal/pets licence and they will not be allowed public access to the animals. This licence is also dependent on whether the cheetahs have secure housing etc. The housing was refused by LDNPA and we believe they have appealed but the Council have had no formal information on this. The Clerk will contact LDNPA for an update.
